For all matters not expressly provided herein, reference shall be made to the Italian Civil Code and the other applicable laws.</p> <p>All disputes arising out of or in connection with the interpretation and the execution of this Agreement, shall be submitted to the exclusive jurisdiction of the competent courts of Rome, Italy.</p> <p>In the event that the Client is a consumer within the meaning of Article 66bis of the Italian Consumers' Code, any disputes related to the Agreement concluded by the consumer shall be referred to the mandatory territorial jurisdiction of the courts of their place of residence or domicile.</p>
